



BROWNSEA YOUTH STAFF REQUIREMENTS AND EXPECTATIONS:

- ✓ Youth staff must be at least 14 years of age, but not yet 18 by the June 13, 2010.
- ✓ Youth staff must have completed the NYLT course.
- ✓ Staff members will live by the Scout Oath and Scout Law at all times.
- ✓ Staff members will present themselves as role models in conduct and uniform.
- ✓ Staff members will attend all meetings associated with this training.
- ✓ Proper advanced preparation is expected for all assignments.
- ✓ All potential youth staff will participate in an interview of at least two adult staff members in addition to the review of their written application materials.
- ✓ Staff selection is subject to the approval of Scoutmaster and the Greater Yosemite Council.
- ✓ The cost to be on staff is \$60.00. This covers the cost of food for the staff development weekends. Staff members will receive a hat (if needed), T-shirts, epaulettes, and name tag that identifies them as NYLT Staff.
- ✓ The Brownsea-Youth Leadership Training is **June 6-12, 2010** at Camp John Mensinger.
